Here's how to tag a new vehicle:

1. Log on to gmfamilyfirst.com and select "Vehicle Tagging System" from the left navigation bar.
2. Click on "Daily Available Vehicle Summary" and look for the column heading "New Vehicles" to identify eligible vehicles.
3. When you've decided on a vehicle, click on "Search and Tag Vehicles" in the left navigation bar and enter the information requested. Be sure to select "Available Now" in the "Window of Availability" field.
4. When viewing search results, please disregard the column labeled "Est. Availability." The vehicles displayed are available NOW.
5. Once you've tagged a vehicle, click on "Company-Owned Vehicle Purchase" to obtain an authorization number.
6. A representative from Company Vehicle Operations (CVO) will contact you by phone to determine which dealership will facilitate delivery. You will have five business days to acknowledge this contact and provide the information needed before you lose the tag.

Other important information about this offer:

- Shipping could take up to four weeks for cross-country delivery
- Since these are new vehicles, you are expected to take delivery of the vehicle that is shipped
- Tag a vehicle that is located near your desired point of delivery to speed delivery of your new vehicle
- Employees may tag and take delivery of two vehicles under this program, however only one vehicle may be tagged at a time
- Eligible incentives will be based on the date you take delivery
